





American philanthropists, charitable givers and humanitarian supporters:

America is advertised as “Land of the Free and Home of the Brave.” That is false advertisement. Francis Scott Key is the author of the famous words: Land of the free and home of the brave. He wrote those words in 1814 and, since 1931, they have been sung as the national anthem of the United States of America. What is far less known is Key’s view on race. In his career as a lawyer and public servant, Key spoke publicly of America slaves as a distinctly different, inferior race of people who were less than human. The “Three-Fifths Compromise” in the U. S. Constitution supports Key’s viewpoint and is the greatest evil that has plagued the American Slave Nation. It has kept the American slave culture away from America’s economic battlefield that Dr. Martin Luther King, Jr. foretold.

The national anthem is false advertisement and the U. S. Constitution must be amended. American slaves are 100% human. They were bred and born in the land of the free, but they are not free. To be truly free, the American slave culture must be able to support itself without having to rely on welfare-handouts and lifesaving support from the culture that bred and enslaved the people and is still holding the people captive (mentally enslaved). America is an economic society. Freedom for the American slave culture can only occur when the people who make up the culture are unrestrained and allowed access to untainted, God-given knowledge and allowed to grow to their intelligence capacity and economic potential.

The American slave culture has never had a chance to grow to its intelligence capacity, nor its economic potential. A few American slaves have been fooled into thinking they have grown to their intelligence potential. They made it to America’s economic battlefield and were allowed to reach their individual economic potential. Some have even reached billionaire status. Not realizing their wealth extends from slavery and is providential, they think they are rich African Americans and their wealth has nothing to do with slavery, nor their people. They think their followers are Africans and their misunderstood freedom and unfounded wealth is all about them. Read: “*African American Oxymoron*.”

Oblivious of their human being, while endorsing ignorance, confirms that rich descendants of American slaves are mentally enslaved. That means all American slaves are mentally enslaved, rich and poor! Until all American slaves are mentally free, none are free. Rich American slaves trying to pass for African Americans won’t coverup the fact that American slaves are mentally enslaved. It just illustrates rich slaves’ cultural ignorance.

If any part of the American Slave Nation is enslaved, the entire American Slave Nation is enslaved. That is why a nationwide press conference, press release, is so vitally important: All descendants of American slaves must receive upgrade intelligence at the same time, or

those who don't receive the good news of slavery will remain mentally enslaved and nothing will change. ASI's press conference, press release, is held so newscasters can do their jobs equitably and make sure this "good news of slavery" gets out on time and spreads nationwide, instantaneously and impartially.

Newscasters and commentators broadcast news about every culture in America, except the American slave culture. They have so far refused to broadcast anything that relates to American slaves. I know this, because I have begged them repeatedly to help American slaves by sharing and broadcasting the truth of slavery; they still refuse. Ignorance makes them think American slaves are African Americans. When they broadcast that American slaves are African Americans, they are broadcasting a lie. The news media is proving to be one of the most ignorant, racists entities in America. The news media has its knee on the neck of the American Slave Nation and we are running out of breath and short of time. It is their job to broadcast the good news of slavery fairly, openly and timely!

America has always allowed a "chosen few" American slaves to slip through the crack of slavery and prosper. During slavery, these fortunate few were called Uncle Toms; today, they are called gatekeepers of the American dream. This divisive, slipping through the crack, act is intentional. It causes ignorant inner-city slaves to think their people are free and prospering; while thinking their economic failure is their own fault, and it is not. Read: "*Black Name, White Game*" and "*African American Oxymoron.*" The saddest part of this oblivious, depressing, scenario is American slave billionaires' (and millionaires') ignorance is ingrained. They have no idea that it is their responsibility to conduct business for their people and make sure their culture is cared for and prospers. American slave billionaires (and millionaires) must be held accountable for their people being discriminated against and left to stagnate in ignorance and poverty. The thought of leading ignorant slaves, or being leaders of the American Slave Nation, has obviously never crossed their minds. That is how ignorance works. Leaders of the American slave culture are so far out-of-touch with reality, they don't understand America, nor who they are, or what is going on around them.

Ignorance is one of the most powerful forces on planet earth. Ignorance gets its power from ignorant leaders. Ignorance keeps its power because overly intelligent leaders are afraid to tangle with raw-untapped-ignorance, because it is unpredictable and highly explosive. You never know when raw ignorance will detonate. America's racial problem is a byproduct of raw, intuitive ignorance, a consequence of the illiteracy that was ingrained into the American slave culture during their incubation into humanity. Ingrained ignorance has depressed the American Slave Nation its entire existence and has proven to be highly explosive, causing race riots and other violent acts throughout history.

Generic ignorance is a psychological sickness that, in one form or another affects all humanity. Racial ignorance is different: It is taught in our school system and negatively affects American slaves. It goes unnoticed, because it is disguised to look like a helping hand. Racial ignorance is easily transmitted and highly contagious but, if approached intelligently, objectively and timely, it is curable. The problem with curing racial ignorance is the same teachers who teach us how to overcome generic ignorance also teach us how to stay racially ignorant through equity, diversity and inclusion programs. America's school system is a haven for the miseducation of the American Slave Nation and the premier headquarters for teaching racial ignorance to blank slate slaves.

Usually, when America has a problem, the task of correcting the problem is assigned to whichever cabinet member, politician or entity that is being paid to correct similar or related problems. Why has no one corrected America's racial discrimination problem? It has been ongoing forever and, directly or indirectly, every American is affected or touched by racial discrimination. After spending billions of dollars dealing with racial discrimination in one form or another, our government has achieved no favorable results. Why aren't politicians, lawmakers, activists and campaigners held accountable for this disgraceful oversight? Racial discrimination has become so commonplace, it is unrecognizable and obviously assumed to be nonexistent.

To eradicate racial ignorance, which is presumed to be nonexistent, our first job is to prove racial discrimination actually exist. That means the raw truth surrounding slavery must be spoken out loud. And that presents a communication problem. Whites would have to say the "s" word, slave and that is worse than saying the "n" word, nigger. Whites would be branded as bigots for speaking the raw, uncooked truth of slavery. They therefore resort to speaking untruths and telling overcooked lies, so they can blend in and be accepted expressively and politically. African American leaders are ashamed that they are American slaves. To keep from being recognized as descendants of American slaves, they speak untruths and tell lies when they claim they are African Americans. Fear of speaking the words American slaves and shame from being descendants of American slaves prevents leaders, white and black, from discussing the negative aftereffects of slavery openly, intelligently and truthfully.

When leaders refer to American slaves as African Americans, it misidentifies the people in question and describes America's racial discrimination problem incorrectly. It makes leaders misrecognize American slaves and misunderstand the negative aftereffects of human bondage. When identifying the slaves that were bred and enslaved in America, the words "American slaves" are correct terminology and the only words that could awaken descendants of American slaves from the hereditary ignorance that is entrenched at the core of the American Slave Nation. "American slaves" are the only words that could conceivably make reparations for slavery become a reality in America's bigoted economic society.

American slaves fought racial discrimination during the Negro civil rights movement. Our leader was killed in action, and we lost our racial discrimination struggle. Negro leaders hadn't acquired updated intelligence that would allow them to associate the words "Negro civil rights movement" to the words "American Slave Movement." They knew they were involved in a "movement" and they knew they were fighting "racial discrimination." They lost the fight, because miscommunication caused the word "Negro" to misidentify the people white America was discriminating against.

Negro leaders had no communication base from which to comprehend they had lost America slaves' "racial discrimination war." When Dr. King was assassination, Negro leaders thought the civil rights movement was over. When America introduced minority programs to calm down rioters and Negro children were allowed to go to white schools, Negro leaders thought they had won their racial discrimination war. Not understanding economic warfare and therefore having no idea how to negotiate cultural business matters, when white America offered minority programs to stop American slaves from rioting, Negro leaders thought minority programs were the prize for winning their hard-fought civil

rights struggle. They had no base from which to realize that cultural warfare is a normal part of conducting culture business and must be negotiated at all times. Cultural warfare will occur and continue as long as business exist and endure. Dr. Norris Shelton wants to negotiate this portion of American slaves' involvement in America's Civil War peacefully, so the outcome will be profitable for everyone. The key to successful negotiation is to make everyone happy.

Prior to Dr. Martin Luther King being assassinated, he directed American slaves, aka Negroes, to the "economic battlefield." Negro leaders, unable to associate the words "economic battlefield" to the words "racial warfare," didn't realize Dr. King was preaching about the 'civil war' they were currently fighting. Unfamiliar with the rules of engagement that control "economic warfare," when Dr. King was assassinated, Negro leaders' couldn't think any further than thinking they were next in line for a sniper bullet. They abandoned the Negro civil rights movement in the heat of battle, ran for cover and vanished from sight. To cool overheated tempers, America introduced minority programs. Violence subsided and the American Slave Movement ground to a surrendering halt.

When the smoke cleared, Jesse Jackson, Ralph Abernathy and other of Dr. King's lieutenants reappeared claiming they were Africans, aka African Americans. Fearful of getting assassinated for being followers of Dr. King, Negro leaders fell into the enemy's trap: They became divided and, not understanding the strategy behind divide and conquer, they abandoned the American Slave Movement and started their own "individual movements" in the form of minority programs and nonprofit organizations. Negro leaders started competing against the NAACP, an organization that W. E. B. Du Bois and other unaware slaves incorporated in 1909 to help "colored people."

Their brains hadn't developed to the point where they could look back, visualize their surroundings and internalize that the shooting phase of the Civil War was fought to free American slaves from metal chains, only. The Civil War continues; supporters of former President Donald Trump proved this when they stormed Congress on January 6, 2021 in a bid to thwart the certification of Joe Biden's election victory.

The people Dr. King was leading weren't Negroes, colored people, nor minorities. They were ignorant slaves who were recently freed from the chains of slavery, misnamed Negroes, misidentified as colored people and classified as minorities. Wearing genetic blinders, Negro leaders still can't take-in the big picture and visualize America as she truly is and understand that the American slave culture is mentally enslaved. They can't visualize where and how slavery fits into America's economic battlefield picture.

When the rioting ceased, American slaves remained in plain eyesight but vanished from psychological inner sight. Racial discrimination took on an entirely different appearance and camouflaged itself to look like a helping hand. Jim Crow became law, sided with racial discrimination and attacked the Negro civil rights movement head-on, and took no prisoners. Dr. King was killed. The American Slave Movement was captured, and the American Slave Nation was sentenced to economic starvation, without parole.

Racial discrimination is still holding the American Slave Nation hostage, but leaders don't realize this. The golden rule of economic warfare is: "To kill a snake, cut off its head." When the enemy killed Dr. King, the head of the American Slave Movement was cut off. The only contingency plan in existence was when Dr. King told Negroes to head to

the “economic battlefield.” Negro leaders were preachers, not businessmen. “Economic battlefield” is business terminology. Ministers who survived Dr. King had no idea what economic battlefield meant. They were stalemated in ignorance and their people have since stagnated in poverty. American slaves lost their racial discrimination war and were cast further into mental bondage (slavery). The American Slave Nation is still sitting on death row awaiting execution: (cultural genocide, by economic starvation).

ASI’s mission is to unravel America’s racial discrimination problem, win the vanquished civil rights war and get paid for defeating racial discrimination. ASI will start by educating American slaves properly, truthfully and timely. When American philanthropists and other charitable givers partner with ASI and follow “*American Slaves, Inc. Renaissance Plan*,” ASI will be able to conduct “culture business” in the name of the American Slave Nation openly and intelligently. We can’t lose: “*American Slaves, Inc. Renaissance Plan*” creates a win/win, economic windfall for all Americans, black and white. ASI is the sole representative of the American Slave Nation and is duly authorized to make this lucrative business offer.

ASI is marketing an authentic American made product. Black Lives Matter, Urban League, NAACP, SCLC, NAN and other “money laundering” organizations that take credit (and get paid) for helping descendants of American slaves, no matter what we are wrongly called, are selling a cheap, fictitious, watered-down, weak, reproduction of American slaves. ASI is selling the “real deal!” Our product is 100% American made: *WE ARE AMERICAN SLAVES!* — *AND WE ARE PROUD OF IT!*

ASI is committed to removing misunderstood hate from the slavery equation and chasing unconscious shame from American slaves’ mindset. Once these ignorance’s are addressed and eradicated, ASI will be able to get the aftereffects of slavery straightened out and the American slave culture under control. When ASI takes control of the American Slave Nation, Black Lives Matter, Urban League, NAACP, SCLC, NAN and other organizations are invited, encouraged and ‘instructed’ to join the American Slave Movement officially and profit under ASI’s guidance. Following ASI, they will be able to help their people properly without changing their company’s name, hierarchy status or functioning title. They won’t have to lower their pecking order positions, nor shuck their cultural rank. Joining ASI will allow Black Lives Matter, NAACP, SCLC, NAN and other organizations to keep functioning as they are without missing a beat. They won’t lose money: ASI’s inherited mission is to show them how to make money!

The many civil rights organizations that take credit for helping so-called “African Americans” are not making money. They are misrepresenting a mentally enslaved people while stealing crumbs that fall from the reparations for slavery table. ASI is offering them a “seat at the reparations for slavery table!” Then they could make some real money for representing the real/right/authentic people. If anyone, or any organization, think they have a better business plan that strategizes how to lead American slaves to America’s economic battlefield than ASI, it is their inherited duty to challenge ASI’s plan and takeover the American Slave Nation. If they have a better plan, ASI will gladly follow the better plan. If these organizations don’t have a better plan, commonsense should tell them it is their inherited duty to follow ASI’s plan. Dr. Shelton wants American slaves to have the best economic battlefield plan available, no matter who drafted it.

Leaders who survived Dr. King never realized the Negro civil rights movement was an offshoot of the American Civil War, or that they had lost an important fight in the war that they were supposed to win. Once the Negro civil rights movement was abandoned, American slaves were immediately branded as Africans (foreigners) and slickly renamed African Americans (visitors). Misidentification caused American slaves to be exiled from their parent culture and abandoned in their motherland. Once Dr. King was out of the way, racial ignorance became commonplace; slavery intensified and racial discrimination settled into an immoral, yet highly effective norm.

If civil rights organizations and other cultural establishments want to help the oppressed people who were bred in America during slavery and are still mentally enslaved, they (we) must work together and follow the only plan that is designed to help descendants of American slaves. ASI is the only organization in America and the world that had the brainpower, took the time and invested blood, sweat and tears to draft the only renaissance plan in existence specifically designed to liberate American slaves from “mental slavery” and guide the American Slave Nation in the future. ASI’s plan will jumpstart the American Slave Movement, liberate American slaves from racial ignorance, rectify the negative aftereffects of slavery and solve America’s longstanding, racial discrimination problem.

ASI is laser focused. Our drive is to organize the American Slave Nation into a superior moneymaking machine, officially! To accomplish this lofty goal, publicity is vital. Once American slaves are organized into an economic force and get impartial media attention, philanthropists and other charitable givers could inject nonprofit funds directly into ASI to fund “*American Slaves, Inc. Renaissance Plan*,” the only plan strategically designed to nourish a hungry people who are the offspring of the world’s most lucrative economic environment but are, nonetheless, suffering economic starvation in their homeland.

When Dr. King was gunned down in 1968, the American Slave Movement came to a dreadful halt. It was jumpstarted in 2001 when American Slaves, Inc. was incorporated in Kentucky. In 2009, when ASI hosted American Slaves, Inc. Identity Forum at University of Louisville, American slaves were accurately identified as American slaves academically, read: “*America’s Little Black Book*” and “*Gatekeepers of the American Dream*.”

Reviewing the results of American Slaves, Inc. Identity Forum, it became clear just how racially ignorant PhD’s and other educators at University of Louisville truly were. Understanding how the U.S. Department of Education collaborates internally, if educators are that racially ignorant at University of Louisville, educators are likewise racially ignorant at every university in America. To reeducate “educated ignorance,” I needed more educative ammunition; so, I stopped waging war at University of Louisville and started shoring up the foundation of the American Slave Nation. I dropped out of sight and spent the next few years traveling the country, getting involved in racial skirmishes and collecting historical data related to the business of slavery.

My research and writings include documenting John Brown, a white abolitionist who sacrificed his life trying to free American slaves before the Civil War began; some say John Brown started the Civil War. Instead of being rewarded for his humanitarian effort, he wound-up getting hung for being a traitor against America. It has always been against the law for anyone to help American slaves — and it still is. My writings include the riot that erupted in Ferguson, Missouri, when Darren Wilson a white police officer gunned down

Michael Brown, an 18-year-old American slave. I traveled to Ferguson to meet with the Chief of Police to discuss racial peace. I wrote about Breanna Taylor who was murdered by white police officers in Louisville, Kentucky. Read “*Covid-19 Windfall*” and other American Slave History books that teach us about the business of slavery. Authentic history books validate American slave’ existence and state our case more clearly.

In September 2022, when I published my 25th American Slave History book, titled, “*The High-Cost of Teaching Ignorance*,” God Told me: Lighten up on writing educational books: Get back to fighting educational crooks... So, here I am, and here I will stay until I win this phase of American slaves’ education/economic battle. ASI is declaring all-out war on racial ignorance, cultural poverty and miseducation of the American Slave Nation — and we are taking no prisoners.


The groundwork in the foundation of the American Slave Nation has been laid. American Slave History books that sanctify the underpinning of the American Slave Foundation and clarify the business of slavery have been written and published. The guiding strategy that will navigate the American slave culture to true freedom has been drafted, evaluated and accepted. I am now ready to position the American Slave Nation on the American Slave Foundation. Positive positioning will override negative stagnation and jumpstart the business of slavery.

The most significant step to positioning a brand-new nation on its foundation is to assemble a national leadership team (presidential cabinet) with learning capability and fighting spirit that is willing to follow my orders as I follow God’s Orders: God Instructed Norris Shelton to declare war on racial ignorance, defeat racial discrimination and secure economic freedom for the American Slaves Nation. I must therefore attack and defeat those who teach ignorance and, make no mistake, I am prepared to fight ignorance and racial discrimination to my death.

Florida Governor Ron DeSantis’ administration must think to some extent the way I think. He obviously realized that American slaves are being miseducated. Knowing democrats would attack him, he stepped over the line and blocked a new Advances Placement course on African American studies from being taught in high schools, saying it violates state law and is historically inaccurate. He is right. Teaching African American Studies to ignorant American slaves is not only historically inaccurate; it is immorally wrong. Teaching ignorance to American slaves defies God’s Will that American slaves survive as American slaves and be taught they are American slaves. White America never bred African Americans. White Americans bred American slaves. The terminology, African Americans, wasn’t used to identify/misidentify American slaves until After Dr. King was funeralized.

To guarantee that this stage of the American Slave Movement is successful, incoming leaders must understand the past and realize how it affects the present. When warring against ignorance, fighting spirit and stable leadership/followship are upfront requirements. A transparent chain of command must be structured and recognized. Pecking order power must be exercised properly, justifiably and without hidden agendas. Leadership strategy for American slaves is spelled out in “*America’s Little Black Book*” and other books I have written. The strategy is simple: Every American slave, especially billionaires, should pattern their lives after Norris Shelton’s life. To understand this business strategy

and comprehend how it works and how it would benefit American slaves, read and understand Norris' earlier books: *“Alley Rat,” “Crabs in a Barrel,” “Black Name, White Game,” “Gatekeepers of the American Dream”* and other American Slave History books that narrate Norris' life.



Businesses in America's free, economic society are controlled by documentation and other forms of recordkeeping that create paper trails that justify the existence of businesses. The paper trail that American Slaves, Inc. is creating for descendants of American slaves is their indispensable, foundation support. It justifies American slaves' existence, supports their human being and safeguards their birthright. My job is to conduct "culture business" for the American Slave Nation. I must therefore reconstruct the paper trail of slavery based on absolute truth and undeniable facts. Godly, Untainted Truth is the only binding element strong enough to fuse the American Slave Nation together and support it for a thousand-years... and beyond...

Absolute truth reveals that American slaves are a new strand of humankind that were raped into existence in America's biased economic society. For over 246-years, white slave owners and slave masters mated with (raped) their black female slaves at-will. Cultural inbreeding by the dominant white culture with black captives for that length of time bred an assimilating mindset. It makes America the mother nation of the American Slave Nation. Economic truth reveals that slavery is America's undeveloped offspring-strength and the cornerstone in America's business foundation. Uncovering paternal facts of slavery allows us to take a comprehensive look at the economic power of slavery. Understanding the hidden truths of slavery helps us devise better ways to strategize for a peaceful, nonviolent future.

After 400-plus-years of mental enslavement, the time has finally arrived for American slaves to take ownership (advantage) of their preordained foothold in America's business foundation. And that presents a problem. American slaves were bred to be ignorant and have been mentally enslaved their entire existence and are still being miseducated. To gain even a toehold in America's intelligent, economic, foundation, establishing American slaves proper, precise, unarguable, identity is the first intelligence that must be documented in the

slavery paper trail. Documenting unarguable truth is the only way American slaves' existence can be unquestionably verified.

Once American slaves' proper identity is established and they are recognized as America's offspring culture, they can be elevated to their proper position in America's economic hierarchy. Proper elevation and positive positioning will cause basic intelligence to collide with innate mother-wit. When that happens, cultural upgrade will happen. When untapped knowledge energizes descendants of American slaves' undeveloped intellect, the American Slave Movement will come alive and descendants of American slaves will be allowed to enter America's economic battlefield. From there, they can advance to reparation for slavery timely and peacefully.

Facts surrounding slavery expose an indisputable, genetic people-trail made up of successive information that shows the birth and growth of the business of slavery from 1619 to 1865. Once the paper trail of slavery is completely uncovered, it will show the coverup of the business of slavery from 1865 to 2023. It will expose that descendants of American slaves are the natural/unnatural born "issue" of the business(es) of slavery and the offspring culture of white America. Paper trails expose, regulate, legalize and control businesses. They show the growth of businesses and also the demise of businesses. Paper trails point out mistakes made in the past and, when studied in reverse, they show how to correct blunders leaders are still making in the present.

ASI drafted its renaissance strategy from studying the paper trail of slavery. The plan explains American slaves' birth and birthright and shows how to make reparations for slavery happen without turmoil being the consequence of exerted effort. American slaves' paper trail exposes the unchallengeable history of the American Slave Nation and validates American slaves' inheritance. It justifies reparations for slavery.

History documents the United States of America as the "melting pot of the world." Different cultures come from near and far to compete for America's wealth and share her abundance. American Slave History is being written to substantiate this fact; with a few glaring oversights: American slaves are not represented as an American people in America's melting pot. American slaves were bred in America, yet they are misidentified as foreigners in their homeland and disconnected from their mother country. That means American slaves are not in the competition to share America's wealth and abundance. Misrecognizing the people who originated in America's highly competitive, biased, economic society automatically breeds economic discrimination against the innately bred people.

In an economic society, ignorance is the mother of racial discrimination. It breeds economic starvation and will eventually render the weakest nation in an economic society to economic genocide, and then to cultural genocide. The America Slave Nation is the weakest nation in America's melting pot and is being genocided right before our eyes. If slavery is not straightened out, economic starvation will continue until America's offspring culture is wiped out. If the negative aftereffects of slavery are not eradicated, America's economic foundation will continue decomposing until it eventually collapses. Omitting American slaves from America's melting pot and misrepresenting descendants of American slaves in minority programs subtracts from America's economic strength. It puts America in danger of collapsing from within and being taken over by foreign enemies acting as inhouse friends.

Every American is invited to join the American Slave Movement and become a part of the paper trail that validates the American Slave Nation. There can be no greater honor than having American Slave History record that you helped rescue the American Slave Nation from economic starvation. God does not discriminate. Politics and religion don't come into play when rescuing American slaves from economic starvation. Politics and religion bring too much emotional baggage to the reparations for slavery table. They slow progress and distract from business going forward. At this juncture of the American Slave Movement, politics, religion and all other emotional entities must take a backseat to business. Dr. King was suggesting this placement tactic when he told Negroes to engage the economic battlefield. Once "*American Slaves, Inc. Renaissance Plan*" is adequately funded, politics, religion and other emotional entities can resume their inherited functions in the American Slave Nation and assume their rightful positions in the American Slave Movement following a strategic plan that includes everyone. ASI is not eliminating politics, religion and other emotional entities from the slavery equation. ASI is just placing them in their correct position and exact order of necessity so they can be effective.

Human rights and other crusading organizations are not being excluded: They are finally being included. According to "*America's Little Black Book*," Dr. Shelton promised that, under his leadership, no slave gets left behind, and that includes other organizations. There has been enough division — it is time to come together. Diverse organizations have an important part to play in the future wellbeing of the people. General orders are to properly identify American slaves, bring diverse organizations together and provide leadership for the American Slave Nation. This positive merger will straighten out the business of slavery and allow organizations to start prospering while doing their inherited jobs correctly.

This proposal is a groundbreaking, "nation-building," business offer that has staggering potential. Those who would like to help elevate American slaves from ingrained ignorance and racial depression to basic intelligence and economic freedom, please step forward. This is an invitation to be a part of establishing leadership in the American Slave Nation. It is one of many starting points in the American Slave Movement and, according to business protocol: First in gets the Lions share at each level. Those who help fund this level of "*American Slaves, Inc. Renaissance Plan*" will become second generation board members and be elevated to positions where they would have a say in controlling the American Slave Nation and guiding the American Slave Movement. They would be in a position to oversee American slaves' lucrative birthright (reparations for slavery).

Early participation would assure they are inline to share the economic reward that emanates from following a well-thought-out business strategy and from a job well-done. A get acquainted conference call or zoom meeting will be arranged. Those interested in helping renaissance the American Slave Nation will be introduced. James Elliott, Pastor of New Jerusalem Missionary Baptist Church in Louisville, Kentucky, asked Norris Shelton, President of the American Slave Nation to speak at his 40th Year Anniversary Celebration. Norris Shelton accepted the invite to speak and, while speaking, he challenged Rev. James Elliott to organize ministers and start a "Descendants of American Slaves Ministerial Alliance." The climax of Dr. James Elliott's 40th Year Anniversary Celebration was that he accepted the challenge. He agreed to establish an "American Slaves Business Incubator" to train descendants of American slaves to enter America's economic battlefield: Those were Dr. Martin Luther King's instructions.


Dr. James Elliott brought Dr. Luonne Rouse, of Unification Theological Seminary to the reparations for slavery table. Dr. Rouse didn't waste any time. He immediately got in touch with Louis Cameron Gossett Jr. and invited him to the reparations for slavery table. Mr. Gossett answered Dr. Rouse invite with one word: "yes." If he follows through, he will be the first movie star to help lead his people. Mr. Gossett is an Oscar-winning actor and founder of Eracism Foundation, a 501 (c)(3) nonprofit public benefit corporation dedicated to bringing about social change: Exactly what American and American slaves need.

State of ASI and position/situation of the American Slave Movement:

The white culture is the parent culture to the American slave culture; but legally, American slaves don't exist. There is no documentation that proves American slaves were bred in America, or that white Americans bred American slaves. Descendants of American slaves have wound-up scattered throughout America, misidentified as Africans, nicknamed African Americans, classified as foreigners and treated worse than illegal immigrants. Because of ignorance and self-shame, whites have allowed American slaves, their offspring culture, to evolve into an ignorant, misguided people who are inherently alienated from their mother country, intentionally divided from each other but, suffering economic starvation together.

Descendants of American slaves are currently in the process of waking up from the racial ignorance that whites ingrained into the American slave culture at their inauguration into humanity. Unfortunately, there is no hard evidence to substantiate this fact. The paper trail of slavery is disconnected. I am writing American Slave History to connect the paper trail of slavery and, until I finish making this connection, descendants of American slaves' presence will have to suffice as evidence that American slaves existed during slavery and still exist now. Slave masters and owners feared if the truth surrounding slavery was known, the International Court of Justice (sometimes called the World Court) would prosecute them for cultural rape. Slave masters and owners destroyed all evidence that could incriminate them for breeding slaves. When they destroyed evidence of their rapist actions, it disconnected the paper trail of slavery and caused American slaves to be excluded from American History and World History.

If American History had been recorded correctly, history itself would have already tried and convicted America of being a slave breeding nation. The coverup of slavery is causing American slaves to suffer racial exclusion, the lowest/highest form of racial discrimination. Trying to coverup slavery to avoid being prosecuted for raping the American Slave Nation into existence, is foolhardy: That which is hidden in darkness will someday come to light: History will Judge our character and our being: No matter how thorough we try to coverup our despicable acts, history will expose hidden injustices and show how our time on earth was spent.



Descendants of American slaves are finally coming together. Dr. Lee Gill, University of Louisville, and Dr. Norris Shelton, American Slaves, Inc., took the first step and came together November 7, 2022, to resume the American Slave Movement.

Snide omissions and misleading doubletalk cause American History to be incorrect. It causes descendants of American slaves to have no confirmed history at all. It is my job to connect the missing dots of slavery and record American Slave History truthfully. Then it can be added to American History and World History. I have written twenty-five American Slave History books. American Slave History is taught online from these books through Bellarmine University, a private Catholic university in Louisville, Kentucky, by Kathleen Parks, Kentucky County Commissioner.

This document is an indispensable part of American Slave History. It invites white America to connect to American slaves and American slaves to connect to descendants of American slaves. It invites all Americans to connect (come together) for the humanitarian-cause of rescuing American slaves from economic starvation. Philanthropists are being summoned to the forefront of the American Slave Movement to help shore up a longstanding weakness in America's business underpinning. Rescuing American slaves from economic starvation would strengthen America and make America great — for the first time...

November 7, 2022, I met with Dr. Lee Gill, Vice President for Diversity, Equity and Inclusion" at University of Louisville. I delivered a pointed, business proposal, asking University of Louisville to be the first university to educate American slaves properly and Dr. Gill to be the first educator employed by a public university to teach descendants of American slaves truthfully.

ASI has since updated the proposal. Now, every charitable giver, human rights organization, university, college, business, philanthropist, church and individual, is invited to become involved in the American Slave Movement. And here is why: To rectify the negative aftereffects of slavery, organizations must work together as a rectifying unit. American Slaves, Inc. (ASI) Mission Statement: *“To convene the American Slave Movement and legitimize the American Slave Nation: To enlighten America on the plight of American slaves and the promise of freedom made to descendants of American slaves: To educate the American Slave Nation truthfully and fully: To create empowering strategies that will rectify the negative aftereffects of slavery: To emancipate the American Slave Nation from government dependency.”*

Enslaving humanity is a business endeavor that started thousands of years ago, long before the Americas were discovered. Selective slave breeding (nation rape) started in North America in 1619 and continued until 1865. The American Civil War was fought and American slaves were freed from America’s womb (slavery). When they started moving away from being physically enslaved, the American Slave Movement started.

Most Americans assume, when the American Slave Nation was raped into existence, it was a physical act only. They take for granted that chains, whips, hangings and other forms of brutality kept American slaves shackled to slavery. Updated Intel from *“American Slaves Brain-Scan”* reveals that slavery was 10% physical and 90% mental. This tells us that violence and brutality were merely tools of the slavery trade used to instill fear into blank-slate-humanity. Violence and brutality terrorized American slaves and engulfed the mindset of the American slave culture. Innocent human beings were systematically programmed to fear seeking freedom: To seek freedom, frightened slaves would have to oppose brutal whites. Opposing slave masters and owners in any form would invite the violence they had been programmed to avoid. Dr. King’s death was one of many cruelties orchestrated to make a point and accomplish the, fear of seeking freedom, goal.

The metal chains that kept American slaves physically enslaved were removed. The mental chain that made American slaves accept slavery as a way of life was never addressed. This could only mean the slave mentality is still attached and the American Slave Nation is still mentally enslaved. Ignorance still controls 90% of descendants of American slaves’ “human being.” American slaves have been physically free for more than 150-years and yet, they are still ignorant of their human being and can’t rationalize to which culture they belong. Descendants of American slaves don’t know they are supposed to be free; they have no idea what freedom is. Ignorance causes American slaves to accept slavery as a way of life — it’s all we know.

American Slaves, Inc. proposes to partner with America's philanthropists to reconvene the American Slave Movement and educate descendants of American slaves properly. Proper education would repair American slaves' defective mindset and set them free mentally. This upgrade would strengthen America and initiate world peace.

Dr. Martin Luther King, Jr. led the American Slave Movement when American slaves were misidentified as Negroes. The movement was misnamed the civil rights movement and marketed as a campaign to abolish racial segregation, racial discrimination and disenfranchisement of Negroes. Dr. Norris Shelton is succeeding Dr. Martin Luther King. He is taking over the American Slave Movement and updating racial terminology. His mission is to correctly identify American slaves, educate them properly and guide descendants of American slaves into mainstream America in an orderly fashion. This effort will correct the negative aftereffects of slavery and upgrade a people that were bred to be ignorant and are now being tutored to stay ignorant. In order for cultural upgrade to renaissance the American Slave Nation, three progressive steps must be taken: Awakening, Identification and Litigation.

American slaves' cultural upgrade was introduced when Dr. Martin Luther King, Jr. directed American slaves (then called Negroes) to America's economic battlefield. When Dr. King was assassinated, his lieutenants, not understanding who they were, or what Dr. King meant by economic battlefield, allowed American slaves to be misidentified as Africans and nicknamed African Americans. Misidentifying American slaves as Africans and addressing them as foreigners caused the American Slave Movement to veer off course and grind to a halt unnoticed: Upgrade never happened...

Awakening, Identification and Litigation are sequential steps that will jumpstart the American Slave Movement, get it back on course and headed in the right direction toward the economic battlefield. Details how to apply these steps are spelled out in "*America's Little Black Book*" and other books authored by Dr. Norris Shelton. To enter America's economic battlefield, descendants of American slaves must be correctly identified, tutored properly and their leaders must be taught to conduct culture business in honor of the American Slave Nation. Dr. Shelton's 5th book, "*American Slaves, Inc. Renaissance Plan*," explains how to train and qualify American slaves to conduct culture business. It directs descendants of American slaves to America's economic battlefield and shows them how to gain profitability once they arrive. The plan is designed to be self-sustaining. Three upgrade steps are explained herewith:

- 1) **Awakening:** American slaves were born into America's biased economic society in secrecy, unannounced and misrecognized. Misrecognizing God's Chosen People causes racial discrimination to be a persistent, hereditary evil that has always burdened descendants of American slaves. Racial discrimination persists because America has yet to claim American slaves as her offspring culture. Disowning American slaves, America is denying descendants of American slaves their God-given Birthright. Educators who have the capacity to understand cultural evolution (regeneration of humankind) should be able to grasp that descendants of American slaves were procreated in America, baptized in ignorance and are now in the process waking up from the deep-sleep of ingrained-illiteracy.

Awakening is the first step to curing American slaves' mental illness and upgrading America's deplorable, racial situation. American slaves' mental awakening is not a hindrance to whites, nor is it another camouflaged stumbling block put in the way of descendants of American slaves. It is instead the long-overdue racial-upgrade America has been desperately needing but clearly avoiding. The time has come for descendants of American slaves to wake-up, standup and make positive advancement toward economic success. This can be a beautiful awakening, or an ugly nightmare. A peaceful, nonviolent awakening (Dr. King's directive) depends upon America's philanthropists digesting upgraded intelligence and accepting their responsibility to help those in need.

Philanthropist organizations have evolved into racial discrimination havens disguised to look like helping hands. They must start using commonsense and showing compassion to those in need. They must distribute charity fairly. Acting timely is important, because misconception and malicious lies are the only glues that are holding America's fragile, racial situation together. The rise in cultural upheaval and police brutality tells us that these two evils are fast losing their adhesiveness.

Descendants of American slaves are overburdened with self-shame and self-hate. Feeling inferior to other human beings "instinctively," because that is what society has always dictated, is a heavy burden to bear eternally when simple truth will ease unconscious depression. ASI is petitioning American philanthropists to do their job fairly. Donate to help alleviate the unnecessary burden American slaves are suffering; help expose the truth of slavery; subsidize descendants of American slaves' existence; help educate the American slave culture properly while we still have time. Stop using the "good ol' boy" system to earmark and allocate charity to underserving organizations that you control. There was no closure to the American Civil War, nor to slavery. If American slaves' awakening is not handled properly, intelligently and timely, America could be torn apart at the weak seam of racial discrimination, and it will be philanthropists' fault for not heeding this warning.

During the awakening phase of the American Slave Movement, which has already started, descendants of American slaves' minds-eye will come wide-open. After 150-years of mental enslavement, older American slaves have all but given up on gaining true freedom. They have accepted their lesser station in life in American. They probably won't react to advanced intelligence and cultural upgrade. Once ASI gets younger American slaves over their fear of reading and they read American Slave History books, they will understand who they are and realize their culture was bred and born in America and they are America's only begotten offspring. When they realize that, by law, America is their official inheritance, they won't accept continued maltreatment and racial abuse in their homeland. Following unaware leaders who don't understand racial negotiation, they will become emotional, overreact violently and could reignite the American Civil War. American slaves must be encouraged to read American Slave History books, so they will know how to take care of business and avoid committing ignorant acts.

If racial ignorance stays in control of America slaves' cultural awakening, racial depression will cause racial issues to eventually erupt out of control and then implode. If America mishandles American slaves' awakening, it could awaken the American Civil War and turn it from a "cold-war" back into to a "shooting-war." And here is why:

Misidentifying American slaves at the close of the American Civil War, which was fought to free American slaves, tells us that the Civil War didn't end. It continues today as a cold war, because nothing was negotiated or settled regarding American slaves (the cause of the war). American slaves weren't even mentioned in the negotiations, if there were any. ASI is petitioning America to help educate American slaves properly and renegotiate slavery fairly. It is the only way America could enjoy an intelligent, peaceful, nonviolent "awakening of the American Slave Nation."

- 2) **Identification:** In 1865, when the shooting phase of the American Civil War ended, American slaves were released from physical slavery, misidentified as colored people and branded as Negroes. When Dr. King was assassinated, American slaves were misidentified as Africans, branded as African Americans and told they were minorities. In 2001, American slaves were properly identified, legally incorporated and branded as American Slaves appropriately. In 2009, American slaves were correctly identified as American slaves at the college level during *University of Louisville Black High School Education Summit* and *American Slaves, Inc. Identity Forum* that was held at U of L campus. Kentucky Governor, Stephen L. Beshear authenticated the event by awarding ASI a "Proclamation" that proclaimed *American Slaves, Inc. Identity Forum* the start of American Slave History and an important part of American History: Read "*Gatekeepers of the American Dream;*" "*Miseducation of the American Slave Nation*" and "*The High-Cost of Teaching Ignorance.*"

American Slave History books explain that descendants of American slaves are suffering through racial discrimination that goes unnoticed, camouflage to blend-in and hideout in plain-sight. A partnership between ASI and America philanthropists would guarantee that when the American slave culture comes fully awake, descendants of American slaves will have an authentic helping hand already in place that consist of economic support, top-of-the-line educational tutoring and shrewd leadership that American philanthropists could provide.

The American Slave Nation was bred and born in America and is only 400 years old. Compared to other cultures that are thousands-of-years-old, American slaves are a newborn-baby-culture, the youngest natural, unnaturally, born nation on planet earth. After 400-years of fermenting in racial ignorance, it is past time for descendants of American slaves to gain untainted knowledge of who they are, so they can attain true independence and enjoy economic freedom in their homeland.

To gain independence, American slaves must be organized according to America's cultural guidelines and trained to function in America's financial arena. To attain economic freedom, American slaves must have business-minded leadership that understands who they are, who they are leading and where they are headed. Leaders must have a legible destination, secure mode of transportation and an estimated time of arrival. Once leaders are upgraded with untainted truths surrounding slavery, they should be able to recognize that inbred ignorance and "*Miseducation of the American Slave Nation*" are causing American slaves' economic demise. Once leaders acquire and digest racial intelligence, they must come together on one accord and strategize how to turn economic starvation into cultural prosperity. American slaves must be tutored properly according to their misunderstood birth, their overlooked adolescence and their

lucrative birthright that is hiding right before their eyes: but securely hidden behind blinding ignorance.

Ever since the American Slave Nation was raped into existence, American slaves have been severely miseducated and unmercifully abused. The name “American slaves” denotes loudly and clearly that American slaves need “special education.” Our government is indebted to providing the special education that will give American slaves (America’s offspring culture), a proper send-off into mainstream America. The problem with America supporting American slaves is American slaves must be correctly identified, legally organized and nationally recognized as an American bred culture so support can reach the right people. “AMERICAN SLAVES” is the proper identity of America’s only offspring culture. If American slaves are not properly identified, their reparations for slavery (birthright) will continue going to other cultures, as it is now.

American slaves need, deserve and are owed special education, economic support and “paternal guidance” from America their mother country. Slavery in America is American slaves’ “uninterrupted connection” to human existence. American philanthropists are being offered the opportunity for American Slave History, American History and World History to record that American philanthropist faced their inherited, charitable giving responsibility and provided the economic support and superior leadership that freed the American Slave Nation from mental slavery. If they do their jobs correctly, history will record that American philanthropist had the mental capacity to learn something new. They learned how to save descendants of American slaves from economic starvation. They rescued the American Slave Nation from ethnic genocide.

- 3) Litigation:** America is indebted to the American Slave Nation for forced-mind-manipulation, mental contamination and unpaid-slave-labor that are causing American slaves to suffer economic starvation. When a debt is owed, it doesn’t just go away because the injured party doesn’t sit on your doorstep waiting to get paid. Interest doesn’t stop accruing on a debt because pressure is not directly applied or felt. If civil crimes are committed in America, or if civic laws are broken, law enforcement will detain criminals; judges will interpret law, and courts of law will impose penalties, but it is still left to the injured party to file charges for restitution in a civil court and litigate those charges. American slaves couldn’t file charges for being mentally enslaved, depressed and brutalized: Doubletalk in the U. S. Constitution allowed Confederate judges and slave owners to interpret the “Three-Fifth Compromise” in the U. S. Constitution to mean that American slaves were animals, or 3/5 human. Animals can’t file charges against humans, so no formal charges were filed for American slaves.

American slaves were clearly the innocent victims of slavery, but they were ignorant of their human being then and descendants of American slaves still are. American slaves have never understood their human existence. They have never been represented by human law, or according to human law. The American Slave Nation was raped into existence, enslaved, abused, banished and abandoned. Descendants of American slaves are still denied justice and left to wander in ignorance following ignorant leaders who think they are Africans (African Americans). That pretty-much sums up “American Slave History.” America philanthropists are being offered the opportunity to help rectify

American History, so justice can be rendered to the American Slave Nation peacefully and without negative incident. It is their job!

There cannot be a “statute of limitations” for the crime of slavery in America. And here is why: *If American slaves’ deep-seated ignorance is not cured within the timeframe that Dr. Norris Shelton specified, inbred ignorance will congeal into a hardened mass and become everlasting; at which time, the genocide of the American Slaves Nation would have been carried out successfully. American slaves will still walk among us, but they will be a “dead people walking.”*

If American philanthropists join forces with ASI, economic support and special education could be administered to descendants of American slaves timely; economic starvation could be overcome and genocide would be avoided.

American Slaves, Inc. stratagem in action: At the height of Norris Shelton’s extensive business career, he was often called in to straighten out and save minority owned businesses that were on the verge of bankruptcy and sometimes already bankrupt from going under. He always achieved the sought-after success. Dr. Shelton says: *“We have been looking at slavery and America’s racial situation emotionally, which is absolutely wrong. Emotion has caused us to see American slaves’ economic situation backwards. American slaves’ dire situation is actually an overwhelming business opportunity. I can save American slaves from economic starvation and show American philanthropists how to make “mega bucks” in the process. Slavery was business; it is still business and always will be business. To conduct business successfully, product, management, marketing and sales are essential; with product being the main essential; because, if you have no product, you have nothing for management to market and sell.*

“Slavery in America is a business endeavor that possessed a superior product but still wound-up bankrupt. If any business possesses a superior product, which American slaves were (and still are) and windup bankrupt anyway, it is clearly a managerial (leadership) problem. I will therefore takeover leadership of the American Slave Nation, incorporate American slaves into a marketable product and advertise the upgraded product to America through American philanthropists. Once marketing is initiated, the sale finalized and “American Slaves, Inc. Renaissance Plan” accepted, I will lead American slaves into America’s economic battlefield in an orderly fashion with white America’s blessing. 
